



## Professional Licensure Disclosure Statements

### Clinical Medical Assistant (CMA)

The Clinical Medical Assistant (CMA) program at Hawaii Medical College does not lead to professional licensure. Medical Assistants are not licensed by state regulatory boards in any U.S. state or territory.

Hawaii Medical College has determined that completion of the Clinical Medical Assistant program does not require professional licensure for employment in all U.S. states and territories.

Graduates may choose to pursue voluntary national certification through third-party certifying bodies. Certification requirements are established by the certifying organizations and are not regulated at the state level.

### Healthcare Administration – Billing and Coding (HABC)

The Healthcare Administration – Billing and Coding (HABC) program at Hawaii Medical College does not lead to professional licensure. Healthcare billing and coding professionals are not licensed by state regulatory boards in any U.S. state or territory.

Hawaii Medical College has determined that completion of the Healthcare Administration – Billing and Coding program does not require professional licensure for employment in all U.S. states and territories.

Graduates may pursue voluntary professional certifications issued by national certifying organizations. These certifications are not required for employment and are not regulated at the state level.

### Pharmacy Technician

The Pharmacy Technician program at Hawaii Medical College is designed to prepare students for employment as Pharmacy Technicians. Pharmacy Technician licensure, registration, or certification requirements vary by state and are established by individual state boards of pharmacy.

Hawaii Medical College has determined that this program meets the educational requirements for Pharmacy Technician licensure or registration in states and territories

where national certification through the Pharmacy Technician Certification Board (PTCB) is sufficient for state registration or employment.

States and territories where the program meets educational requirements include: Alabama, Alaska, Arizona, Arkansas, Colorado, Connecticut, Delaware, District of Columbia, Florida, Georgia, Hawaii, Illinois, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maine, Maryland, Massachusetts, Michigan, Minnesota, Mississippi, Missouri, Montana, Nebraska, Nevada, New Hampshire, New Jersey, New Mexico, North Carolina, North Dakota, Ohio, Oklahoma, Pennsylvania, Rhode Island, South Carolina, South Dakota, Tennessee, Texas, Utah, Vermont, Virginia, West Virginia, Wisconsin, Wyoming, Guam, Puerto Rico, and the U.S. Virgin Islands.

Hawaii Medical College has determined that this program does not meet the educational requirements for Pharmacy Technician licensure or registration in states that require additional state-specific training, experiential hours, or licensure examinations beyond PTCB certification. These states include California, Idaho, New York, Oregon, and Washington.

Hawaii Medical College does not enroll students residing in states where the Pharmacy Technician program does not meet educational requirements for licensure or registration.

Students are responsible for understanding and complying with licensure or registration requirements in the state in which they intend to seek employment. State requirements may change, and students should consult the appropriate state board of pharmacy prior to enrollment.
